President's Report	<p><b>ELECTIONS</b></p> <ul style="list-style-type: none"> <li>● Elections - Have switched to Upland area seats</li> <li>● Three seats up for election - two incumbent and one open seat <ul style="list-style-type: none"> <li>○ Incumbents - Mary Locke, Wes Fifield</li> <li>○ Open Seat - will replace Bob Bennett who is not able to run for the Upland region that is up for election at this time.</li> </ul> </li> </ul> <p><i>A motion was made to recommend the incumbents in Areas B and E, and to interview candidates in Area D for a possible recommendation once the filing date has closed.</i></p> <ul style="list-style-type: none"> <li>● Moved by Debbie Glenn, seconded by Doug McCully. Motion carried.
